COVID-19 Update on County Operations

MASK UP VIRGINIA

Help reduce the risk of transmission

- Starting Friday, May 29, any person age 10 or older must wear a face covering at all times while entering, exiting, traveling through, and spending time in indoor public settings.


TCSD Update

TCSD Bonds

- Originally issued in 2002 to fund TCSD infrastructure
- Refinanced in 2012 to achieve more desirable interest rates and debt service schedule
- Debt service is supported by the ad valorem rate as well as 55% revenue sharing on the increased value of commercial properties in the TCSD


2020 refinancing

- Bonds closed on July 29, 2020
- \$12.1M in gross debt service savings
- \$8.5M in net present value savings
- Percentage savings of refunded bonds 15.2%



- Intersection Improvements & Signals – Live/Active





Potential Route 288 Interchange





Goochland County Public Schools Recognized as a “School Division of Innovation” by the Virginia State Board of Education

Last week, the Virginia State Board of Education recognized 15 Virginia school divisions as “School Divisions of Innovation” for designing and implementing alternatives to traditional instructional practices and school structures that improve student learning and promote college and career readiness, and good citizenship. The divisions are the first to earn the designation, which was authorized by the 2017 General Assembly.

“I think it is fair to say that innovation has never been more important in public education than today as schools across the commonwealth and nation focus on improving distance learning in the face of a pandemic, while addressing inequities in opportunities and outcomes,” Board of Education President Daniel Gecker said. “I congratulate the leaders of all these school divisions for creating innovative plans to address the challenges in their schools and engage their students in deeper learning across the curriculum.”

Goochland County Public Schools was recognized for work in developing a “deeper learning index” to measure depth of student learning and for expanding authentic work-based experiences. “No matter how challenging the circumstances, our division continues to stay focused on providing our students and our families with the most engaging and innovative experience possible”, said Dr. Jeremy Raley, Superintendent. “To be recognized among only 15 of the 132 divisions in the Commonwealth with this honor is a testament to the talent of our staff and the support of our School Board and our community”.








